- Technical Bids must be accompanied by a Bid Security in the form of Pay Order / CDRs amounting to Rs. 2,500,000/- in favour of DDO (IMBS), CDA. The prospective bidders shall upload scanned copy of Bid Security on E-Pads.

- The Bids will be opened by using EPADS publicly on the same day at 11.30 A.M in the presence of the procurement committee and Bidder's authorized Representatives who choose to attend the opening session to be held at the office of Director (MBO), CDA, Room No. 26, Block-III, G-7/4, Islamabad.
