- 6. The prospective bidder is also required to submit their bids (with complete documents) online through E-PADS at http://eprocure.gov.pk before opening date. Original bids in accordance with the provisions of rule 36(b) of Public Procurement Rules 2004 and terms and condition defined in the bidding documents.
- 7. The bid security of all bids will be deposited in CDA bank account and same will be returned after the acceptance of the contract with the successful bidder.
