Name of firm should be clearly mentioned on instrument. The prospective bidders shall upload scanned copy of Bid Security on **E-PADS** and original will be submitted to the office of Dy Director Special Project Div-II, CDA before opening of Bids. Pay order is not allowed.
- 4. The prospective bidders shall upload scanned copy of certictae that is required on Judicial Stamp Paper worth Rs.50/that their firms are not involved in any litigation.
- The prospective bidders shall upload scanned copy of certictae that is required on Judicial Stamp Paper worth Rs.50/for non-relationship in CDA.
- The prospective bidders are also required to submit their Bids online through **E-PADS** at **http**;//**eprocure.gov.pk** before opening date. Original bids in accordance with the provisions of Rule 36(a) of Public Procurement Rules 2004 and terms & condition defined in the bidding documents must be submitted at the address mentioned below on or before **26.05.2025** at **11:00 AM**.

The Bids will be opened publicly on the same day i.e. **26.05.2025** at **11:30 AM** in the presence of Bidder's authorized Representatives who choose to attend the opening session to be held in the office of Director Special Project, CDA, Room No.50 Old Naval Headquarters, Markaz, G-6, Islamabad.

In case of total bid amount is less than 10% below the NIT amount the bidder shall submit additional call as performance security equal to the difference between NIT amount and total quoted amount less than 10% of NIT amount the additional performance guarantee shall be submitted along with the bid. Bid having the rates below 10% of NIT without additional call deposit will be rejected.
