- 2. The bidding shall be conducted in line with the Rule 36(a) Single Stage Single Envelop procedure prescribed under Public Procurement Rules 2004, E-PAD Procurement Regulations 2003 and is open to all potential bidders registered in the E-Pak Acquisition & Disposal System (EPADS).
- 3. Bids must be accompanied by a Bid Security duly generated from firm's own account should be in the form of Pay Oder/CDR's in favor of **D.D.O (East)**, **Environment Wing, CDA**. The prospective bidders shall upload scanned copy of Bid Security on E-PADS and original Bid Security /CDR's **before 12:00 (Noon) dated 26-05-2025**.
