- For using the EPADS, unregistered bidders may first register on website <https://eprocure.gov.pk> in case of any technical difficulty in registration or using EPADS, the prospective bidders may contact PPRA, technical team.
- The bidding shall be conducted in line with the Single Stage Two Envelop Procedure of the Public Procurement Rule 2004. And any regulations, Regulatory Guides, Procurement Guideline or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
- The e-bidding documents as per regulations, containing detailed terms and conditions, specifications and requirements etc. are available for the registered bidders on EPADS at (<https://portal.eprocure.gov.pk>).
- All electronic Bids must be accompanied by a Bid Security in an acceptable form (**pay order**) in favor of DDO, DHS, CDA/MCI. The bid documents can be downloaded (free of cost). The prospective bidders shall upload scanned copy of Bid Security on EPADS. Original bid security must be submitted to the procuring agency on or before the closing time of bid submission failing which the bid shall be rejected.
- The electronic bid must be submitted by using EPADS on or before **08th May, 2025, 11:00A M**. Manual bids shall not be accepted. Technical proposal will be opened by using EPADS publicly on the same day at **11:30 AM** at DHS, St-58, F-11/4, Islamabad in front of bidders and purchasing committee. The envelope as financial proposal shall be retained in the custody of procuring agency that will be opened later on.
- All items applied for should be inclusive of all taxes applicable.
- MCI reserves the right to reject all or any of the tender as per PPRA rules-33(i).
