- The Bids will be opened publicly on the same day at **12:00 Noon** in the presence of the procurement committee & Bidders' authorized Representatives who choose to attend the opening session to be held at the office of the Director (Water Supply) Room No.16, CDA Old Naval Headquarter Building, G-6, Islamabad.
- In case the total bid amount is less than 10% below the NIT amount, the bidder shall submit call deposit as performance security equal to the difference between NIT amount and total quoted amount less 10% of NIT amount .That is required performance security = NIT amount –total bid amount -10% of NIT amount .This call deposit shall be addition to the earnest money for the work and shall be deposited at the time of submission of bids, not carrying the performance security shall be rejected, The performance security of the successful bidder shall be released after completion of the project.
- The Firm providing unsubstantiated and /or incorrect information are liable to legal action and disqualification from the bidding.
- The eligibility criteria of the firms with the relevant experience i.e atleast three number of work orders in last two financial years may be upload with the bid.
