

HIRING OF CONSULTANTS FOR PREPARATION OF FEASIBILITY STUDY FOR REGULAIZATION/UPGRADATION OF ILLEGAL SCHEMES / SETTLEEMNTS IN ISLAMABAD.

Islamabad, the capital city of Pakistan, is recognized for its modern infrastructure, planned urban design, and natural beauty. However, over the years, unregulated growth has led to the emergence of illegal housing schemes and unplanned settlements within the Islamabad Capital Territory (ICT). These areas suffer from poor infrastructure, inadequate public services, environmental degradation, and unhygienic living conditions, which stand in sharp contrast to the city's planned sectors. Their existence not only undermines the urban character of Islamabad but also poses administrative, social, and environmental challenges for the Capital Development Authority (CDA).

2. To address these issues, CDA has planned hire a consultant to undertake a comprehensive feasibility study for the upgradation, rehabilitation, and regularization of such schemes and settlements.
3. **The project area will include all the illegal schemes/settlements spreading on area approx. 200,000 Kanals, in Islamabad Capital Territory. These schemes/settlements are grouped together in three projects, on the basis of different Zones of Islamabad.**
4. The study will include baseline surveys, GIS-based mapping, community profiling, and infrastructural assessments, followed by the preparation of layout plans, regulatory frameworks, and cost estimates. The ultimate aim is to integrate these settlements into the planned urban fabric of Islamabad in line with CDA byelaws, National Reference Manual (NRM) standards, and Sustainable Development Goal (SDG) 11, thereby improving quality of life, promoting inclusivity, and elevating the capital's image at both national and international levels.
5. The Consultant with the requisite demonstrable experience in Town Planning and its relevant Financial and Legal matters may submit its relevant profiles along with following information:
 - a. Registration with Federal Board of Revenue (FBR) or other relevant tax authority
 - b. Registration with Pakistan Engineering Council (PEC /PCATP) (In case of Consortium, the PEC registration of technical and environmental / social consulting firm members, as applicable, is required) and Town Planners & Landscape Architects registered with PCATP.
 - c. In case of Consortium, the Consortium Agreement shall be submitted pursuant to clause 2.26
 - d. The Consultant is not black listed by any department of Government of Pakistan or any provincial governments in Pakistan. An affidavit from bidder shall be signed and submitted with Technical Proposal (In case of consortium, every consortium member firm should provide affidavit) (Section 8).
 - e. For a Consortium to be eligible for bidding, every member of Consortium firm should place at least one (1) Key Professional Staff and at least two (2) Key Professional Staff of Lead Member firm of Consortium.
 - f. The relevant experience of Lead Member and other Consortium member firms is mandatory.
