SHOWCAUSE NOTICE UNDER SECTION 49-C &, 46-B OF THE CDA ORDINANCE 1960, READ WITH, CLAUSE-5 (1) & (II) OF THE ICT (ZONING) REGULATION, 1992 (AMENDED IN 2010) DEMOLISH/REMOVAL OF WORK/STRUCTURE/BUILDING AND STOPPAGE OF USE OF LAND, ILLEGAL/ UNAUTHORIZED HOUSING SCHEME NAMELY USMAN ENCLAVE , ZONE-4, ISLAMABAD.

During site visit it has been observed that Development Works for Housing Scheme and Construction of Buildings is being carried out by the sponsor of the scheme which is illegal/ unauthorized Housing Scheme in Zone-IV, Islamabad.

- This Work/ Structure / Building is being Constructed / Erected and Land is being used in contravention of the provisions of CDA Ordinance 1960, ICT Zoning Regulation 1992 and Islamabad Capital Territory Building Control Regulations 2020. Therefore, you are directed to demolish/remove the said Work. Structure / building and to desist using the land, within 10 days of the issuance of this Order.
- Public Notice was published in National Dailies wherein all the spensors of illegal/ Un-authorized Housing/ Farm-Housing Schemes were advised in their own interest to obtain approval from CDA by submitting their Layout Plans as per the relevant provisions and approved planning standards/ land use percentages, however, nothing in this regard has been received.
- It is made clear that if the above Order is not complied with within 15 days, tho above illegal work/structures/buildings will be removed. Demolished and use of land stopped by using Force (including Police Force) by CDA the cost will be recovered, by CDA for the construction of work/structures/buildings and use of land in contravention of the provisions, as aluresaid.

The Director Public Relation, CDA, is requested to advise Print and Electronic Media to advertise Private Projects/ Scheme only with prior Permission/ NOC/ Approval of CDA, in best interest of the public at large. It is further requested to share this letter with the Print & Electronic Media for awareness of the General public. For any information Director Regional Planning may be contacted.
