3. Technical Bids must be accompanied by a Bid Security in the form of Pay Order / CDR generated from bidder/supplier own account amounting to Rs. 8,000,000/- in favour of DDO (P&CA), CDA. The prospective firms/consultants shall submit the original CDR in the office of undersigned on bid submission deadline and also upload scanned copy of Bid Security on E-Pads.

Firms/Consultants may seek clarification or any queries during the pre-bid meeting, or even after the pre-bid meeting from the office of the undersigned but prior to seven (07) days before the last date for submission of bids.
