The prospective bidders are required to submit Bid Security/Earnest Money (CDR) amounting to as above mentioned works in favour of Deputy Director Market & Roads Maintenance North, CDA issued from any schedule bank **against firm's account**. **Name of Firm should be clearly mentioned on instrument (Call Deposit/CDR)**. The prospective bidders shall upload scanned copy of Bid Security on E-PADS and original will be submitted **Seven (07) Days before i-e 10.02.2026** opening of Bids & **Pay Order is not acceptable**.
4. **The prospective bidders shall upload scanned copy of Certificate that is required on Original Judicial Stamp Paper for each tender worth of Rs. 500/- that their firm are not involved in any litigations.**
5. **The prospective bidders shall upload scanned copy of Certificate that is required on Original Judicial Stamp Paper for each tender worth of Rs. 500/- for non-relationship in CDA.**
6. The prospective bidders are also required to submit their Bids online through E-PADS at <http://eprocure.gov.pk> before opening date. Original bids in accordance with the provisions of Rule 36(a) of Public Procurement Rules 2004 and terms & condition defined in the bidding documents.
7. In case the total bid amount is less than **10% below** the NIT amount, the bidder shall submit call deposit as performance security equal to the difference between NIT amount and total quoted amount less 10% of NIT amount. This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project.
8. Participants/firms must submit attested copies of relevant documents with original bid security/CDR's.
9. **Work-related information may be sought from the office of Deputy Director Market & Roads Maintenance North, CDA.**
10. **In case of any gazetted/occasional holidays the tenders will be opened on the next working day.**
11. **The bid security of all bidder will be deposited in CDA bank account and same will be returned after the acceptance of the contract with the successful bidder.**

The Bids will be opened publicly at **Sr. No 1 to 2 on 18.02.2026, & Sr. No. 3 to 4 on 19.02.2026 at 11:30 AM** in the presence of Bidder's authorized Representatives who choose to attend the opening session to be held at the office of Director Market & Roads Maintenance & Deputy Director Market & Roads Maintenance North, CDA located at Old Navel Head Quarter Room No. 40 & 66 Sector G-6 Melody Islamabad.
