- 5. The meeting started with the recitation from Holy Quran.
- 6. Minutes of the 8th Board Meeting were confirmed by the CDA Board.
- The CDA Board and hoped that the decisions taken by the Board would be in the best interest of the Authority. He said that in the past there had been complaints of short notice for holding the Board meetings but after the assumption of office he has already issued instructions that there should be notice of at least one week before the meeting and the working paper should be circulated to all the members 7 days in advance. The Board did not agree to the proposals submitted by the Legal Adviser in the Summary on the ground that latest amendments in the CDA Ordinance provide for payment of the property acquired at market value. Hence there was no need to grant additional rehabilitation benefits mentioned in the summary. As such Legal Adviser was asked to draft Land Acquisition Regulations, to bring them in conformity with the latest amendments in the CDA Ordinance.

It was decided that Mr. Tasnim Ahmad Siddiqui, Secretary Sind Government, who had worked as Director General Katchi Abadies and had a particular concept of Rehabilitation of Katchi Abadies, be asked to visit all these katchi abadies and give his recommendations. It was further decided that with a view to controling further expansion of existing katchi abadies triangular pillars should be constructed around the katchi abadies in G-8/1 and F-6/2 to fix their limits.
