- 6. Meeting commenced with the recitation from the Holy Quran by Brig. Nusrat Ullah Member (P & D).
- 7. The minutes of 31st 3rd and 4th Board Meetings for the year 2005-2006 were confirmed by the Board.
- 8. The agenda items were taken up for discussion and following decisions were taken:-

The owner has failed in his responsibility to adhere to building regulation and has major violation which can not be regularized ordinarily. However in view of the fact that Hospital has already been constructed for Neurological patients, Board decided to regularize the construction by imposing fine @ Rs. 1000/- per Sft. of the total covered area i.e. basement + four storey falling in setbacks which is approximately Rs. 1,67,50,000/-. However, exact calculations be made as per actual construction at site.

The Board decided to reduce the rates of water tanker supply for the residents of Chak Shahzad Town for domestic complaints from Rs. 500/- to Rs. 250/- per trip in view of close proximity of the model village and sectoral area.
