5.1 PROVISION OF LAND TO PUNJAB BOARD OF REVENUE. 10731/1299/BM/'16 28-04-'16/5TH PUNJAB IN CHAKLALA RAWLAPINDI).

DECISION:

The Board after due deliberation, agreed with the proposal placed at para 10 of the summary in principle to set up Children Hospital by Government of Punjab subject to finalization of terms and conditions as per rules and all mandatory codal formalities.

DECISION
