- After review, the CDA Board took up items included in the agenda for the current meeting one by one. Brief account of the discussion/deliberations held and decisions taken are summarised below:-
 - 7.1 Regularization of allocation of site for Jamia ul-Aloom Islamia Al-faridia, North of E-7 Approval of Building Plan.

- for Jamia-ul-Aloom Islamia Al-Faridia in the north of E-7 Islamabad measuring 9,364 square yards may be allotted on 33 years lease basis (extendable for similar two terms). The Annual Ground rent will be payable at the current rates in terms of the existing policy of the Board.

 The rent will be payable in advance every year.
- b) The Management of the Madrassa will construct the required number of toilets with proper Sewerage System, which will be connected with CDA's Sewerage Lines. A suitable clause to this effect will be incorporated in the terms and conditions of the allotment after getting vetted from Consultant (Law).
