- Meeting commenced with the recitation from the Holy Quran 5. by Brig. Nusratullah, Member (Planning & Design).
- Then agenda item was taken up for discussion and following 6. decisions were taken:-

DECISION

The Board decided as under:-

- The Board approved the extension of contract of all the three officers for another one year i.e. from 08-02-2007 to 07-02-2008.
- The Board approved the payment of Dearness Allowance @ 15% to all the three officers w.e.f. 08-02-2007.
- iii) The penalty @ 500% per tower be charged from the Companies those have established their BTS towers in Islamabad without permission of the Authority.
- The electricity charges be recovered from firms / iv) companies those are using electricity of CDA for neon/tube light/flash lited fitted Sign Director Municipal Administration and Director E&M (Maintenance) to work out the expenses. DMA to recover that expenses from the concerned companies/firms. The issue be finalized within 15 days.
- v) The Recovery Unit to make efforts for the searching of new sources of revenue generation.
- vi) Bye-laws of Advertisement and BTS towers be revised. A detailed study regarding installation of BTS towers in developed countries be carried out and report be submitted to Board.

- vii) Notice may be served to M/s Kitchen Kozine for using open space as car parking and appropriate action be initiated with the help of Planning Wing and Enforcement Directorate.
- viii) Director General (Services) with the coordination of Director Municipal Administration to establish of Fiber Structure for the parking of Fire vehicles within two months.
- DMA to arrange training in Pakistan and abroad for fire fighters.
- DMA to arrange seminars for public motivation and fire security.
- xi) Director Municipal Administration to arrange talk shows on Television.
- x) In the mean time for the construction of permanent parking for fire vehicles, PC-1 to be prepared by Director Municipal Administration.
- xi) Director Municipal Administration to coordinate with Mr. Shaukat for training and purchasing of fire items and preparation of PC-1.
- xii) Planning Wing to identify water hyder points in every sub-sector of Islamabad for fire vehicles.
- xiii) DMA to arrange fortnightly review meetings regarding revamping of Islamabad Fire Service.
