The available school plots in existing and new sectors be identified. The result/statistics of this survey be shown on a map to ait future planning of the Education sector in Islamabad.

The P&D wing was also directed to come up with the feasible proposals for redefining use of buildings like Pakistan Nazriati Counsel, and Citizen Club at F-9 Park and Sir Syed Memorial Academy G-5.
