- 6. The minutes of the 2nd Meeting of the CDA Board were confirmed. As regards confirmation of the minutes of the Special Board meeting held on 10-11-1998, 30-11-1998, 17-12-1998 and 6-1-1999 it was observed by the Chairman that as per decision of CDA Board details of accepted and rejected demands of CBA may be submitted to the CDA Board for consideration.

Review of Implementation of previous decisions taken in 1st Board Meeting held on 5-1-1999.

7. The Board reviewed the implementation status of the decisions taken in the Board Meeting held on 5-1-1999. Secretary to the Board explained the implementation status. Further observations made by the Board are as under.

The agenda for the meeting was then taken up. Salient points of discussion cisions are as follows:-

Waiving of extension surcharge of plot allotted to MASHAL for 81 establishment of Social Welfare Centre in Model village Margalla Town, Islamabad

Decision

The case was deferred with the direction that a self contained summary be brought before the Board. The NGO be also asked as to whether it would complete the building in one year. Information regarding registration status of the NGO be also obtained.

8.2 Restoration of allotment for amusement park in Sector F-9, Islamabad.

Decision

The Board decided to make an offer to restore the plot subject to fulfilment/completion of the following conditionalities and obtaining an affidavit on stamp paper from the ex allottee that if he did not comply with the afore said conditions the offer of the Authority to restore the plot would stand null and void:-

- Dues of Annual Lease Money & AGR etc. along with delayed payment charges upto 11-2-1998 are paid within 30 days. In future, if any payment is delayed beyond one month, the allotment shall be liable to be cancelled.
- ii) Restoration charges (to be worked out by the Costing Section) are paid within 30 days.
- iii) An undertaking is given that the project shall be completed within 15 months from the date of the restoration. In case he fails to complete the project within that period, CDA will be at liberty to cancel the allotment or charge extension surcharge as may be fixed.

- by it from time to time. In this context, a construction plan will also have to be submitted within 30 days.
- iv) Financial credibility from any scheduled bank or a branch in Islamabad/Rawalpindi of a bank of international repute is furnished.
- v) Submits performance bond valuing Rs. 10 lac from a scheduled bank.
- vi) The court-case is withdrawn unconditionally within 15 days.
