- 3. Meeting commenced with the recitation of "Holy Quran" by Syed Safdar Ali, Secretary CDA Board. Thereafter agenda item was taken up for discussion and following decisions were made:-

AUCTION OCTOBER 2023: PRINCIPAL APPROVAL FOR AUCTION OF 11847/1419/BM/'23 COMMERCIAL PLOTS +HOSTEL PLOTS + FRUIT, VEGETABLE & MEAT SHOPS + RESIDENTIAL PLOTS IN DIFFERENT SECTORAL AREAS / ADMINISTRATIVE ACTIONS TO BE TAKEN FOR CONVENING AUCTION.

#### **DECISION**

The summary and multimedia presentation was presented by the Member (Finance) and Member (P&D), CDA. They apprised that Board approved the proposal for auction of residential and commercial properties situated across sectoral areas and schemes in its 12th Meeting, held 04.09.2023. The Auction Committee convened a number of meetings and conducted visits of plots to physically determine the status of availability of services and infrastructure. Law Wing also consulted for clearance of litigation (if any) of subject plots to be offered in the auction. During this review, the Auction Committee observed issues in various plots on account of legal, infrastructure and possession status and other issues.

After due deliberation and information / input on the summary, the board decided the following:-

- a) Approved the proposed plan of auction of residential and commercial plots in Table 1 of Para 4 and detail mentioned at Para 5 of the summary.
- b) Approved the inclusion of Plot No.16-D of F-8 Markaz and Plot of Petrol Pump Service Area-2 of Bhra Kahu Bypass in the instant auction brochure, as recommended by the auction committee.
- c) Parking area for Hostel plots as per regulations for apartments. Further FAR will be 1:6 with 70 percent ground coverage. One floor will be utilized for commercial.
- d) FAR for I&T Center will be restricted to 1:4.
- e) Auction will be held from 17th to 20th October at Jinnah Convention Center Islamabad.
- f) Approved the proposed auction committee contained at Para 6 of the summary to supervise and oversee the Auction proceedings.
- g) Approved the draft Auction Brochure, containing terms & condition, mode of auction, mode of payment, planning parameters and location plans etc.
- h) Hotel Plots will be auctioned subject to approval of the Federal Government and Estate Wing shall forward the case to Federal Government for seeking approval through Ministry of Interior.

### **DECISION**

#### **DECISION**
