The summary on the subject was presented by the Director Architecture. He mentioned that the Project Director (Works) has already called tenders for the construction of the houses for Dte. General Post Offices on the basis of the design prepared by the CDA. Since this is a deposit work, the design as approved and desired by the sponsoring department has to be used and for that matter, the Project Director may consult the Dte. General Post Offices. While scrutinizing the design, the Dy: Director B&BC was asked that such elements which are not strictly covered by the relevant regulations should not be considered. The design should be scrutinized strictly in accordance with the regulations. The design should be cleared/approved by the B&BC subject to the conditions indicated in para 7 of the summary.
