DECISION

The CDA Board, after due deliberations accepted the bids of 19-plots mentioned at Sr. No1,3 to 9, 11 to 19, 21 & 22 of the Para-4, of the summary, and did not accept the bids for 03 - plot, mentioned at the serial No. 2, 10 & 20 of Para-4 of the summary. The Board also decided to constitute a committee comprising representatives of the Estate, Planning, Finance, and any other formation as deemed technically fit/appropriate, with a mandate to advise/suggest estimated sale prices of the above 03 x rejected plots. The committee shall further determine the estimated sale values of plots, in the areas, where price-adjustments are essentially required, due to change in the planning-parameters, locations and other pertinent factors. The nomination of the committee, alongwith detailed TOR's shall be submitted for perusal of the CDA-Board, in the due course of time.

DECISION

A joint Summary with a Title of "APPROVAL OF THE MINUTES OF ALLOTMENT SCRUTINY COMMITTEE (ASC) ALLOTMENT OF AGRO FARMING PLOTS HELD ON 09-10-2018" was provided by the Member(Estate), CDA at the time of opening of SBM session, wherein, after due deliberations, it was unanimously decided by the CDA-Board, that above claims are liable to be rejected, under Clause -8 (i), (3), (5) of the Islamabad Displaced Persons Rehabilitation Policy 1996, which categorically defines the eligibility criteria for allotments of rehabilitation of Plots. The applicants, as per contents of the summary, were compensated formerly/once, in accordance with the prevailing Islamabad Displaced Persons Rehabilitation Policy 1996 (IDPRP-1996). The Board, however sought verification of the furnished affidavit's by the claimant(s)/applicants in question, as well as of all those being received in identical cases, and in case of any fake, forged and bogus affidavit's, FIR's be registered against the defaulters. .
