DECISION

On the request of Saudi Embassy dated 18-12-2008, offer of Plot No. 9/A measuring 2.45 acres in Diplomatic Enclave for construction of office cum-residence building for Saudi Military Attache @ Rs. 15000/- per square yard was issued. But due to some administrative reasons, mainly illness of Crown Prince Sultan Bin Abdul Aziz Al-Saud, Minister of Defence Eviation and Inspector General of the Kingdom of Saudi Arabia payment was deferred. CDA Board keeping in view the

special relationship of Pakistan with the Saudi Arabia, brotherly Muslim country and as per offer letter of Plot No. 9/A, Diplomatic Enclave which was issued by the Authority in 2008 on prevailing rates decided that same rates would be charged subject to the condition that the payment of total premium of plot in lump sum be made to CDA before 30-06-2011. The Board observed that the rate of Rs. 800 U.S Dollars, figured out by Deputy Director (E&M-I) is not correct and is being reviewed in consultation Ministry of Foreign Affairs. with Meanwhile permission for start of construction work is allowed.
