- 5. The Board confirmed the minutes of the 2nd Board Meeting held on 15-2-2000.

Review of implementation of Board decisions

- 6. Review of implementation of 1st Board Meeting held on 8-1-2000 and remaining decisions of 1998, 1999, 2000, were explained by Secretary CDA Board. Chairman desired that the implementation of remaining Board decisions should be expedited and compliance report be submitted in the next Board Meeting.
- 7. The items of agenda for the Board Meeting were then taken up. Salient points of discussion and decisions are as follows:-

7.1 <u>Sub-Division and Amalgamation of Industrial Plots in the Industrial Areas, Islamabad.</u>

DDG(P) intimated that the first part of the summary namely Sub Division of industrial plots had been discussed in 2nd Board Meeting held on 15-2-2001 but the sub Division charges @ Rs. 50/- per sq. yard had not been mentioned.

Decision

- i) Discussion on the second part of the summary namely Amalgamation of Industrial Plots was deferred with the direction that Planning Wing should bring out a separate comprehensive summary for the Board.
- ii) Fee @ Rs. 50/- per sq. yard, as sub division charges, for the entire plot, was approved. This may be added at S.No. 1(f), Item No. 8.21 of the Board decision dated 15-2-2001.

7.2 Review of permissibility of "Ware House" in the Industrial Sectors.

7.3 Permission of student fund to CDA Main Account by the CDA Model School.

Decision

- i) The financial powers of the Principal CDA Model School may be placed at par with Directors (Executive) of the Authority and BOI may be got amended accordingly.
- ii) A Joint Account in respect of Students Welfare Fund of the School, may be opened to be operated jointly by the Principal and Vice Principal.

7.4 Recovery Procedure.

- i) The draft CDA (Recovery of Losses, Fines, etc.) Regulation, 2001, was approved by the Board subject to the condition that the period for recovery of losses/advance etc. from employee be enhanced from 15 to 30 days.
- ii) The Gazette Notification may be issued with the approval of the competent authority after vetting by Consultant (Law).
- iii) The provisions of the Regulation should be enforced strictly and list of such cases be put up to the competent authority within seven days.

7.5 <u>Fixation of Transfer fee rates of Multi Storey Economy Flats in F-11, Islamabad.</u>

The transfer fee and property tax in respect of flats/apartments be charged as per their actual use.

7.6 Restoration of bid of Plot No. 1-A, Markaz F-8, Islamabad.

The proposal was not acceded to by the Board. The plot should be put to open auction during forth coming auction.

7.7 Operation/Maintenance of E&M installations of A, B, C, D Blocks, Sectt. Bldgs. Phase-I.

7342/935/2001 748/BF 14-3-2001 "The Board decided that there was no need for privatization of Blocks 'A', 'B', 'C' & 'D' as proposed in the summary. However, 'K' Block should only be manned by CDA employees and no private staff should be employed there after expiry of the contract. Justification/Reed for privatisation of any other Block may be brought up separately by DGS, if required.

7.8 <u>Model Urban Shelter Project Farash, Islamabad</u>.

- Relaxation of provision of Islamabad Land Disposal Regulation, 1993, for allotment of plots to the dwellers of Katchi Abadi "Muslim Colony" may be sought from the Chief Executive's Sectt. through Interior Division.
- ii) One plot in lieu of each Chardewari may be offered in order to avoid future complications.
- iii) Some better name should be suggested for the project.

- iv) PC-I may be forwarded to Interior Division for obtaining approval of the competent forum.
- v) Price of plot calculated on the basis of market value of the land plus cost of infrastructure and the mode of payment given in the Summary was acceded to.
- vi) Title of land may be transferred after completion of the house.
- vii) In order to ensure the removal of the entire Muslim Colony the date of survey of January 2001, may be considered as cut of date instead of 31-12-1995, subject to approval by the Ministry of Local Government.
- viii) Terms & conditions and modalities of the project may be worked out.
