RIGHT OF WAY CHARGES FOR M/S IESCO ON PROVISION OF HT & LT OVERHEAD AS WELL AS UNDERGROUND TRANSMISSION LINES IN THE RIGHT OF WAY (ROW) OF VARIOUS ROADS AND HIGHWAYS OF ISLAMABAD.

#### **DECISION**

The Board decided to charge following amounts/ rates from IESCO:-

### i) FOR OVERHEAD ELECTRIFICATION SYSTEM

The following charges for overhead Electrification System are approved :- (a) ROW Rental Charges (per meter per annum)

Road Network	Upto 12"	13" to 24"	25" & Above
Highways	Rs. 100/-	Rs. 200/-	Rs. 500/-

b) NOC Fee for Main Supply lines

Rs. 1 Million

c) NOC Fee for connection from Main Supply line

Rs. 0.300 Million.

## ii) FOR UNDER GROUND ELECTRIFICATION SYSTEM

The following charges for underground Electrification System are approved :-

## a) NOC Fee (Per case)

0 to 10 Km	11 to 30Km	31to 50km	51 to 100km	Above 100 km
Rs. 400,000/-	Rs. 800,000/-	Rs. 1000,000/-	Rs. 1500,000/-	Rs. 2000,000/-

b) ROW Rental charges (per meter per annum) ROW Rental Charges Rs. 50/-

- c) Rental Charges for crossing Bridges/Culverts (Per Bridge/Culvert per annum)
- Rs. 100,000/- for bridge length up to 30 meters
- Rs. 200,000/- for bridge length from 31 to 50 meters
- Rs. 300,000/- for bridge length from 51 to 100 meters
- Rs. 500,000/- for bridge length more than 100 meters
- iii) The above charges fixed may be charged as per total length of wire i.e. per meter per annum. The rate per meter will be charged according to the total dia for each wire as given in the above. The same rate will be multiplied with the total number of wires on each pole. In order to fix the charges, the rates of NHA for laying underground fiber cable/wire has been taken into account on the pattern of previously proposed rates in case of overhead Electrification system.
- iv) The above mentioned rates will be charged in running meter as per dia of wire irrespective of highway, streets, major roads of sectors, or otherwise.
- v) The area in the instant case does not matter as the above mentioned rates are based on running meter as per dia of wire instead of cost of land.
- vi) Since the above mentioned rates fixed by Finance Wing are based on the rates approved by NHA Islamabad and NHA is taking the rental charges in advance for five years, therefore the same may also be followed.
- vii) IESCO transmission lines from 11 KVA and above will be treated as main lines besides L.T lines upto distribution boxes as far as implementation of charges of NOC for Main Supply line as well as for connection from Main Supply line is concerned.
