#### **DECISION**

- a) Land will be acquired on land sharing basis.
- b) The minimum unit for sharing/exchange of land will be 4 kanals.
- c) 25% of land will be given back to the land owners of cultivable land in the shape of developed plots.
- d) 15% of land will be given back to the land owners of non-cultivable land in the shape of developed plots.
- e) The land owners with holdings less than 4 kanals may pool their land for exchange with CDA.
- f) The shamlat land will be taken @ 15% return to the owners of shamlat in the shape of developed plots.
- g) The land beneath UP will be dealt as per policy vide Clause (a) (b) & (d).

- h) The development charges, at prescribed rates, will be paid by the owners/allottees within specified period after allotment of the plots.
- i) The cost of the BUP is to be paid on the basis of quality & type of the construction to be determined by CDA as per prevailing rules/schedule of the Government.
- j) The land owners, not willing to pool or accept land-sharing formula, will be compensated on market rate basis, as determined by the Deputy Commissioner, CDA.
- k) All the above stated transactions will be affected and carried out between CDA and the affectee/owner, subject to establishment of proper ownership title of the affectee/owner and handing over of clear possession, free of all encumbrances, by the affectee/owner to CDA.
