- birector Revenues introduced the topic of the special meeting and informed that in deference to the approval of the Board in its meeting of 07 March, 1992 to "meter" the entire water supply to residential properties in Islamabad and bring 'flat' rates at par with the 'metered' rates in the meanwhile. An exercise seeking public participation in accordance with the provisions of rules was carried out. A hearing of objections and suggestions received from different sections of the society was held by a Sub-Committee specifically constituted for the purpose. The Sub-

Committee submitted its report capitulating the general thrust of objections and suggestions received.

The matter was discussed at length and the following decisions were taken:

DECISION:

i) The entire water supply in Islamabad should be "metered" and the "flat" rates should be progressively eliminated.

ii) Pending accomplishment of 100% metered water supply in Islamabad, the 'flat' rates of water supply to all residential properties may be increased by 50% instantaneously and at the rate of 50% per anum for three subsequent years till these are at par with the metered rates of water supply.

- iii) All the installed water meters should remain the property of the CDA ("public property") and tempering with thereof and/or willful damage thereto should be rendered a culpable/cognizableoffence.
- iv) The water-meters which are malfunctioning/un-serviceable should be got
 repaired/replaced by the CDA most
 expeditiously.
- would be charged at the rate of the highest bill of the past six months, in case of wilful/delebrate damage/defects to the water meters. Accordingly the water supply contract should be amended, if need be to incorporate the recommendations and as a deterent to damaging the water meters.

on the above decisions should be sent to the Government for approval. Similarly, a reference should be made to ECNE by the Cabinet Division about the rate of increase by 50% per anum stating that 20% increase per annum would take a long time to bring parity

between 'metered' And 'flat' rates. Inflation and water supply costs would neutralize the said percentage of increase in the meantime.

Residential plots allotted to the affectees of Islamabad under rehabilitation policies as an extra legal benefit were regularly changing hands in contravention of the terms and conditions of their allotment. The Cabinet Committee on CDA also took note of the fact and observed that such plots were being transferred under power of Attorney and CDA was being denied the benefit of transfer fee, at the same time causing problems for the Authority. The matter relating to transferability of plots allotted to the affectees was delebrated upon with due deference to the observation of the Cabinet Committee on CDA and it was decided that:
