8. The items of agenda for the Board Meeting were then taken up. Salient points of discussion and decisions are as follows:-

8.1

It was decided that present arrangement should continue till further orders.

Action: Dir E&M (Maint)

Unauthorised construction of mosques in the Blue Area, Islamabad.

Decision

The Board took a serious view of the inaction and negligence on the part of concerned formations of CDA due to which the mosques were allowed to reach their present stage. The Board was placed in a situation where it had not remained possible to abide by the relevant Building Regulations without demolishing the extra construction while any demolishing was bound to affect the stability of structure apart from attracting unfavourable reaction owing to the sentiments attached to a place of worship like mosque. Perhaps the only way was to retrieve whatever was possible by pinning down management of the two mosques to make them accept certain terms and conditions to stem further violations. In order to devise appropriate terms and conditions including formation of a Mosque Committee by the Auqaf Department of not more than five members for each of the two mosques, naming the mosques as per their location etc. A committee comprising Member (Design), DG (Env) and DC, Islamabad was constituted with the advice to prepare appropriate terms and conditions binding the Khateebs/Masjid Committees of the two mosques to strictly adhere to the terms and conditions of the agreement. These terms be compiled by the Committee based on the decisions taken in the Board. These should be put up to the Board for approval before getting them signed from the Khateebs/Masjid Committees. After signing the agreements, CDA may issue appropriate letters of allotment to the Auqaf Directorate to regularise the occupation of these mosques in the name of designated Khateebs/Masjid Committees.

Elaboration of Charter of duties of DDG(Admin) and Division of work between him and Member (A).

A post of DDG (A) will be designated from amongst the existing posts of Directors of Executive Cadre. Based upon seniority cum fitness a Director will be nominated as DDG(A). He will perform the duties as enumerated in the summary in his own pay and scale plus allowances as admissible to other DDGs. He will work under the overall supervision of Member (A) and all files to the Chairman will be routed by him through Member (A). The amendments in CDA Employees (Service) Regulation 1992 be incorporated accordingly. The proposal of placing Director (Parliament Lodges and Hostels) under DG(S) was also examined and it was agreed that this post be placed under DG(S).
