PRESENTATION ON FINANCIAL AND DEVELOPMENT MODEL FOR THE FUTURE DEVELOPMENT OF ZONE-IV, ISLAMABAD.

DECISION

Model presentation for the future development of Zone-IV was made by DDG(Planning) and it was agreed that Zone-IV has great potential to generate funds. Due to green geographical view of Zone-IV this area has great attraction for development of Housing Societies and Farming Schemes on land sharing basis. The Board agreed that financial model for development of Zone-IV

ALLOTMENT OF LAND TO NATIONAL DISASTER MANAGEMENT AUTHORITY IN SECTOR G-5, ISLAMABAD.

DECISION

DECISION

The Board in principle agreed to the following:-

i) To allot an area measuring 15 acres in Sector I-12 to PHA however. Rates shall be determined by the Finance Wing of CDA.



- Remaining 15 acres land adjacent to PHA will be used for construction of apartments and the scheme should be launched by CDA.
- iii) DDG(Planning) will explore 2/3 more pockets from created / retrieved plots in different areas of Islamabad for construction of apartments.
