#### **Decision**

- a) Births and deaths should ordinarily be reported within 30 days of the event and no fee is to be charged for registration of births and deaths reported within this period.
- b) For births and deaths reported beyond 30 days, fine to be imposed as under:-

i)	reported within one year	Rs. 25/-
ii)	reported beyond one year but within five years	Rs. 100/-
iii)	reported after five years	Rs. 500/-

- c) Cost of birth and death certificates issued in the normal course within 7 days
- d) For certificates asked for, searching fee will be charged as under:-
  - i) beyond one year but upto five years
     ii) beyond five years
     Rs. 100/ Rs. 500/-
- e) For urgent supply of certificates within 24 hours: Double fee.
- (f) All hospital/clinic managements within the Municipal area of Islamabad may be directed to report occurrence of death/birth to DMA within 48 hours of happening of event as per provisions of Municipal Bye-laws, 1968.
- g) Registered Dias in Islamabad may also be issued instructions to comply with provisions of Bye-Laws ibid.
