APPROVAL OF LANDSCAPE DESIGNS PREPARED BY M/S. D.L.P.

Mr. Robert Eaten of M/S. D.L.P. introduced landscape designs in respect of the following :-

- i) The Central Square.
- ii) President's House and Security Zone.
- iii) Right of Way of the National Avenue in front of Cultural Group of buildings.

i) President's House & Security Zone.

The Board reviewed the design prepared by Mr. Robert Eaten and after some discussion decided to request Member Technical kindly to go into the question with the Security Staff of the President's House and find out their exact requirements. Final decision was postponed pending a report from Member Technical.

ii) Right of Way of the National Avenue in front of Cultural Group of buildings.

Another design submitted by Mr. Robert Eaten related to the Landscape along the National Avenue In this respect the Board took the following decision:

Both sides of the Avenue should be treated with Chinar trees right up to the south of International Conference/Assembly Building. This treatment shall be resumed from the north road of the Foreign Office up to the Margalla Avenue.

iii) Central Square.

With a view to curtail expenditure involved in its construction and also in order to provide room for ceremonial parades etc., the Board decided to drop the fountain from the landscape design of the Central Square Buildings.

Mr. Robert Eaten was asked to give workable designs in respect of ceremonial steps coming down from the President's House also. However, the plantation plan in respect of the steps and the garden at the back of the President's House will be supplied by Mr. Edward D. Stone.

REMOVAL OF ARBITRATION CLAUSE FROM FUTURE CONTRACTS/AGREEMENTS.

A summary produced by Assistant Law Officer in recommends of removad: of Arbitration Clause from Future Contracts/
Agreements was also considered by the Board. The proposals contained in the summary regarding future contracts shown against item (b) in the Annexure were accepted. The Board also decided to include contracts reglating to purchases and stores including carriage contracts in this category.

III. UN-AUTHORISED CONSTRUCTION IN ISLAMABAD.

A summary presented by Director Municipal
Administration relating to un-authorised construction
additions and alterations in buildings in Islamabad was
also considered by the Board. It was decided that
exercising vigilance and a watch over un-authorised
construction in Islamabad was essentially a Municipal
Function. Therefore, the Director Municipal Administration
should so spread out his staff as to keep a watchful eye
over unauthorised construction/addition alterations. It
was also decided that any request for change, alteration,
addition in the shops in Aabpara Market should come through
the Director, Municipal Administration to the Deputy
Director, Building & Building Control/Directorate of
Architecture.

The Board further decided to delegate its authority to demolish unauthorised construction to the Director Municipal Administration. In future it will not be necessary for the D.M.A. to refer every case to the Board for a decision. He may act on his own giving a 24 hours notice to the unauthorised builders. At the end of which such unauthorised structures may be removed. Final orders in this respect should be issued by Secretary in consultation with Law Officer.
