CDA Board approved the case for establishment of CNG/Petrol Pump subject to following:-

- a) If there are no other old cases on Lehtrar Road.
- b) The applicant will confirm to pay 25% of the market value of the site.
- c) Give an undertaking that if the road needs re-alignment or CDA needs to acquire land, the applicant will give CDA the right to clear any hindrance whatsoever.
- d) The applicant will not claim any damages or any other claims of the sort. Except for land cost actually acquired.

- a) Where the land is susceptible to encroachment and located at sensitive areas, it should be fenced. A suitable/strong design will be prepared by the Structure Dte. and such lands will be indicated by the Directorates of Estate Management and Land & Rehabilitation Dte.
- b) Where the land is not heavily prone to encroachment and is open, it should be demarcated with RCC pillars, at an interval of 100ft. for clear identification.
