- 2. The Chairman, in his opening address, thanked the Administrator, ICT and the Commissioner, Rawalpindi for attending the meeting and affording an opportunity to the Authority to benefit from their expert advice.

3. Before taking up the specific items included in the agenda, Chairman observed with concern that the progress of work on the re-conditioning/rehabilitation of I.J.Principal Road from Faizabad Chowk to G.T Road was not satisfactory. The delay in its construction was causing great inconvenience to the general public. He added that a portion of the road was closed to the traffic for the last about 5 months adding to the miseries of the travelling public. Member (3) explained the present position of the work and the steps taken to expedite its completion without un-due delay. He hoped that the work shall be got completed within a months, time and if the contractor failed to show visible progress, the carpetting shall be got done by the MPO at his risk and cost.

4. Chairman advised the officers of the Authority in general and the Roads Dte. in particular to perform their duties efficiently failing which disciplinary action would be taken. The Board then took up consideration of the agenda items. At the Chairman's suggestion the review of progress of works was taken up first. A brief account of the issues/points which were brought to the notice of the Board and the instructions given by the Board are as follows:-

items including sentry posts, search lights and telephone connections etc., the scope of work had increased and consequently the Finance Wing has been requested to issue revised AA&ES on receipt of which the work shall be under-taken. Director Buildings was advised to get in touch with the Finance Wing at personal level and have the matter expedited.

#### SIS System in the Parliament Building.

D.D.G (Works) stated that out of the . two Channels provided, one Channel has packed up due to some defect in - the Computer and therefore presently only one Channel was operative. feared that in case this Channel also. gave way it will not be possible to conduct the National Assembly proceedings. He added that efforts made to have the defective Channel repaired by the Danish Firm who had provided the system have failed. Member (£) also observed that the attitude of the Firm was least to say discouraging. After some discussion, it was agreed that the Danish Embassy be approached to intervene in the matter and impress upon the Firm to carry out the required repairs so as to bring the second Channel in operation and also make arrangements to impart training to our staff deputed to handle the equipment.

## 3. Approach Road to the Haj Complex.

Member (E) pointed out that the

He suggested that it would be desirable if the access to the Haj Complex be reviewed by the Authority and a proper a proach in line with the over-all development plan of Sector I-14 be provided from within the acquired area. Member Planning was asked to have the matter looked into.

4. Construction of 60 Units Low Cost Houses in I-14.

Director Works stated that 70% work had already been completed and the total work was expected to be completed by March 1987.

Commissioner, Rawalpindi advised that earlier these houses were built the better as he feared that if it was delayed the residents of Katchi Abadi might take the refuge of the Government policy with regard to the settlement of Katchi Abadies and resist their shifting from there.

Taking cognizance of the view expressed by the Commissioner, it was decided that the completion of

The Board observed that since the building had been constructed, it seemed desirable to have the remaining works completed so as to make the building operative. Therefore, it was agreed that revised PC-1 be prepared and the funds required for the additional work be provided to meet the requirement.

## 7. <u>Construction of Roads</u>.

684/18F/SC

Administrator, Islamabad observed that the condition of the portion of Islamabad Highway from Rawat to Airport Junction and of Kashmir Highway from Peshawar Road to Peshawar Mour was critical and warranted immediate attention as it created a very poor impression to the visitors entering Islamabad through the said two approaches. It was explained by Member (E) that Authority was fully conscious of the position and had in fact, taken measures to re-construct/ rehabilitate the said portions of the two Highways and work had already been included in the on going works and funds provided for the purpose during the current fiscal year. Administrator, I. C. T. . observed that in order to improve the quality of road construction in Islamabad the CDA should lay down proper specifications and should pre-qualify only such contractors who had the requisite competence including machinery to construct roads of given specifications. The Commissioner, Rawalpindi also emphasised that the road construction work should be awarded to only such contractors who had the means to construct good, quality roads. Agreeing with the Administrator and the Commissioner, Member (E) said

that procedural/codal formalities
present a great impediment in the
way of awarding contracts to the
contractors capable of constructing
good quality roads. He said that
unless the procedure to award work
to the lowest tenderer was not done
away with it seemed rather difficult
to achieve the objective. However,
notwithstanding the position, the
Authority shall make all efforts to
award contracts for road construction
to the contractors capable of
delivering the goods.

of roads, the Board also considered provision of under-passes/cloverleaf at important junctions so as to regulate the traffic and to control traffic hazards on one hand and to ensure that the purpose of providing Avenues was not defeated on the other.

It was also agreed that proper traffic signals be provided on the Bridge of Faisal Avenue near Zero Point to regulate the traffic at that point.

#### Widening of Link Road to Airport.

The Commissioner, Rawalpindi observed that the Carriage-way should be constructed on the eastern side of the existing road and not on the

Member Planning explained the background of the case with particular reference to the area which would fall under the proposed carriage-way on the eastern side of the existing road. He stated that the area falling on the eastern side of the existing road belonged to the Civil Aviation Authority and C.O.S to the President had already spoken to D.G, Civil Aviation to allow construction of second carriage-way on the area belonging to them. The D.G. Civil Aviation had verbally consented to the construction of road on their land provided expenditure on the shifting of the Aero Club due to the road construction was met by the Government. Member Planning stated that a formal reference had been made to the D.G, Civil Aviation and his reply was awaited. He was advised to send a

## 9. <u>Installation of Stone Crushing Plant.</u>

The proposal contained in the summary submitted by D.D.G (Works) for the installation of Stone Crushing Plant by CDA was considered. Member Planning

stated that a site had been allotted by the Authority to the East and West Crushing Plant on the express condition that they would first meet the requirement of the Authority of the crush material of the requisite aggregates and would only sell such material in the market which was surplus to CDA requirement. He added that the Plant was likely to start operating in a month's time. view of this, development, need for installing a Stone Crushing Plant by CDA was not felt. The Board, however, observed that in case proposed arrangement did not work to the satisfaction of the Authority, proper scheme, in that case, be prepared which should include the operational cost in addition to the cost of machinery etc.

14. Setting up Compost Fertilizer Plant in Islamabad.

The salient features of the summary were explained by D.D.G (Planning). The Board felt that the feasibility had not been examined in association with the Rawalpindi Municipal Corporation. The Administrator, ICT was of the view that the Authority should ensure that a Plant of the capacity which could take care of the garbage of both the cities be installed and it should be ideally located to meet the requirement of the twin cities. He further suggested that it would be in the interest of the Authority if the Plant Management was made responsible to collect the garbage from door-to-door on the terms and conditions to be mutually agreed upon. The D.D.G(Planning) stated that Tarlai Village was selected for the setting up of Compost Plant. Chairman observed that in case the Compost Plant causes any pollution, we may have to shift the site away from Tarlai. He therefore, desired that the pollution effect of the Compost Plant should be ascertained. Finally it was agreed that in the first instance CDA and the Rawalpindi Municipal Corporation should examine the feasibility of setting up

Compost Plant in Islamabad bearing in mind the volume of garbage that would be available and if the scheme sound feasible, proposals for its further processing be made.
