- i) To over come difference of 03 feet we may reduce the size of plots No. 1477 to 1482. The new sizes will be 24'-6" X 50' (136.11 sq. yards) instead of 25' x 50' (138.88 sq. yards).
- ii) In order to adjust the 08 feet difference we may reduce plot sizes of Plot No. 1506 to 1510. The new sizes will be 23'.4"X50' (130.88 sq. yards) instead of 25'X50' (138.88 sq.yards)
- There is a 20 feet wide lane in between plot No. 1517 to 1518. In order to adjust the 11 feet difference, we may reduce the width of this lane of 09 feet. It is important to mention that this residential block is still occupied by the affectees and development work is yet to be started.
- iv) We may re-route 4" dia water supply line encroaching plot No: 1477, 1510 & 1511, G-11/2.
- iv) In future Land Survey will not hand over possession of plots in a curved block without measurement of the that block and in case of any discrepancy it shall be got cleared by Planning Wing.
