- 5. A single point agenda of Budget Estimate 2012-2013 was placed before the Board and allocation of funds in various Heads/Subheads came up for discussion/approval.

6. The summarized Budget Estimates for Financial Year 2012-13 is given as under:-

10152/1234/BM /'12 20-06-'12/12TH

- i) The total outlay of the budget (2012-13) is Rs.28,320.72 (M) which is 18% higher than the previous financial year's budget (2011-12).
- ii) Total Receipts are anticipated to be Rs.29,561.23 (M) during financial year (2012-13) which is 23% higher than the estimated receipts of previous financial year (2011-12). However, Estimated **Receipts** (2012-13) are based on the assumption of relevant formations such as Planning, Estate Management-I & II, Revenue, DMA, PMO etc. will achieve anticipated targets within specified time frame that shall be made available to Chairman CDA & Member Finance.
- iii) The **Development** Budget (2012-13) is estimated to be Rs.16,025.06 (M) which is 57% of total outlay of Budget (2012-13) and 13% higher than the last financial year's budget estimates (2011-12).
- iv) The **Non-Development** Budget (2012-13) is estimated to be Rs.12,295.65 (M) which is 43% of total outlay of Budget (2012-13) and 26% higher than the last financial year's estimates.
- v) A sum of Rs.5,140 (M) has been allocated including 20% increase in "pay & allowances" and "pension" as announced by the Federal Government in the National Budget (2012-13).
- vi) A lump sum provision amounting to Rs.781.430(M) [Maint: Grant + Rev: A/c] has been made for expected rise in "utility charges" such as electricity tariff, suigas, telephone etc.
- vii) 11 Nos. new development projects have been earmarked during 2012-13 and an approximate amount of Rs.2,245 (M) is reserved under Self Financing A/c (2012-13).

- 10 Utilization of funds during Financial Year 2012-13 in various heads of budget allocation will be made under following conditions:
 - a) Funds will be utilized only after approval of PC-I/Revised PC-I, wherever applicable. Concerned Director will be responsible for enforcing financial discipline / propriety and observance of all financial instructions issued from time to time. Performance regarding Revenue collection will be monitored on pre-determined time frame and report to this effect shall be invariably communicated to the Chairman CDA and FA/Member by concerned formations at short intervals. Expenditure Sanction / release of funds will be issued on quarterly basis according to availability of funds, and as per government policy.
 - b) No work of 'maintenance / repair of government houses' would be undertaken in advance prior to vetting of its estimates by the QS Directorate and approval of the Chairman CDA which will be arranged by Member (Engineering). Furthermore, 'maintenance / repair' of government houses done during last 3 years will not be entertained by Maintenance Directorate.
 - c) Allocation out of Maintenance Grant will be made after deduction of obligatory expenses like "pay & allowances" and "utility charges" and 'matured liabilities' for which ways and means have already been cleared by the Finance Wing during 2011-12.
 - d) Funds for new schemes/works under Self Financing A/c have been reserved to the extent of

Rs.4,500 (M). However, a viable plan for launching of new works/schemes under this head would require approval by the Chairman CDA and further distribution of budget will be made on case to case basis for its notification by Finance Wing, subject to completion of all codal formalities.

- e) Award of work on single tender should not be adopted except in acute urgency. Petty works may be clamped together so that it could be awarded through tender / contract as in line with the instructions given in the PPRA Rules. Revision / award of extra work and escalation of any scheme may be discouraged. However, in un-avoidable only circumstances such revision/award/escalation allowed after may be obtaining approval of the Chairman CDA.
- f) All Divisions / Directorates will incur expenditure relating to PSDP schemes and Maintenance Grants provided that confirmations of Funds releasing is obtained from Budget Section (Finance Wing) as well as by the Treasury Division of CDA and expenditure sanctions (ES) will be restricted upto released amount only. Both Director and Dy. Director concerned will be held responsible in case any amount of PSDP assignment account is lapsed on their part.
- g) The **ways & means clearance** of Finance Wing will remain enforce during the Fiscal Year 2012-13 as per past practice in vogue.

DECISION:

"After detail deliberations, the CDA Board has approved the Budget Estimates for financial year (2012-13) amounting to Rs. 28,320.72 (millions) including 'development' expenditure of Rs. 16,025.06 (millions) and 'non- development' expenditure of Rs. 12,295.65 estimated (millions) against the receipts of Rs. 29,561.23 (millions) along with Revised budget ['development' (2011-12)expenditure Rs. 5,747.41(millions) + 'non-development' expenditure = Rs. 8,059.14 (millions) against revised receipts of Rs. 13,953.21 (millions)].

Nevertheless conditions / guidelines for allocation / utilization of Budget shown in para-6 (ii), (v) to (vii) and para-10 (a) to (g) above should be followed strictly in each and every case on merit".
