### **DECISION**

After due deliberation, the summary as proposed was approved subject to the following:

- The plot would be disposed off by the Estate Wing, CDA as per laid down procedures/regulations after fulfillment of all codal formalities.
- Approval from the Prime Minister of Pakistan shall be sought.
- The cost of land would be determined by Finance Wing, CDA.

Furthermore, it was revealed during the briefing that National Library of Pakistan has encroached 20 feet from their specified boundary line towards western side. Consequently, Estate Wing was directed to take immediate necessary action for retrieval of illegally occupied CDA land vacated from National Library of Pakistan and include this land in the road.
