2. Khokhas-cum-Dukanchas.

Member Administration explained CDA's policy in regard to existance of Khokhas-cum-Dukanchas in Islamabad. He apprised the Board that-

- the President of Pakistan had visited various sites in 1979 where Khokhas were located. Under his directions a policy has been evolved by CDA replacing the shabby structures with properly designed Kiosks, Tea stalls and Dukanchas;
- ii. In respect of the newly constructed Khokhas, directions had already been given to the DMA and the General Secretary of the Khokha Association to advise the allottees to take over the allotted Khokhas within a specified period;
- iii. The location of some of the recently constructed Khokhas has been a cause of controversy amongst the shopkeepers of Islamabad and others in view of their close proximity to the Shopping Centres. On the other hand, some of them have been constructed at un-attractive places where there was no likelihood of any business; and
 - iv. a comprehensive summary on this very subject had already been prepared. It was awaiting vetting by the Flanning Wing. This would now be placed before the Board of the Authority in its next meeting.
