Following decisions were taken in the meeting.

No. 2 138/442/7, 1. Approval of building plans for a cinema house in Class-V Centre in Ramna-7.

Director Architecture explained the salient features of the cinema house. It was observed that there was no provision of car park in the cinema. The Board, therefore, deferred the plan with the observation that the owner should be required to provide a car park.

2. Additions/alterations to Habib Bank, Aabpara Branch (Shop Nos.646-648).

The additions/alternations planned were explained to the Board by the Director Architecture. The Board allowed the alterations in the shops, subject to the condition that if the shops are located in I & T Centre and not the shopping Centre it should be explained to the bank that the additions/alterations to be carried out in the premises should not be used as pretext to stay in Aabpara area whenever the bank will be required to move to the proper place meant for banks. The banks are allowed to carry on their business from year to year basis in the shops temporarily.

27/1/942/1/ 3. Construction of Low Cost Houses for displaced persons of Islamabad in Sector I-9, Islamabad.

The Director Architecture explained the violations done by the Construction Companies in the construction of low cost houses for displaced persons of Islamabad. 2. Review of awards in respect of 24 villages.

The Board, therefore, decided that the review proceedings in cases of Chak Beera Singh, Kot Nathial, Sumbal Korak, Maujuan, and Jhangi Syedan may be withdrawn as there was no ground for going in review in these villeges. In respect of other villages, the review proceedings should continue because the owners have gone in appeal in most of the cases and it would be appropriate to wait for the outcome of the appeals.
