 meeting one by one. Brief account of the discussion/deliberations

 held and decisions taken are summarised below:-
 - 5.1 Development Amusement Fark in Capital Park F-9, Islamabad.

Decisions

a) The Master Plan in respect of Amusement Park in Capital Park, F-9, Islamabad, submitted by M/s Pacwest Broup Inc. USA, was approved subject to the following additional terms and conditions:-

- a) The existing location of the Amusement
 Park was changed to the eastern side
 of the Southern Gate (Mehran Gate).
- b) The total covered area of the building
 was restricted to the areas as given in
 the Master Plan of the Amusement Park. No.
 increase in covered area, will be
 allowed, in future.
- c) M/s Pacwest Group Inc. will submit to the CDA the drawings of all the buildings/
 structure to be constructed in the Amusement Park for the approval of CDA.
- d) The shopping area was also restricted to the area which was given in the report of the Master Plan .
- e) Only Enterance Plaza will be of two storey having a height not exceeding 21 ft. whereas all the remaining buildings will be single storey with a height not exceeding 11 ft.
- f) The over all control of the parking area will rest with the CDA and no parking

fee will be charged by the Management of the Amusement Park. However, adequate parking facility will be developed to cater for the requirement of Amusement Park as well as for other visitors of Capital Park.

 - iii) On complete fabrication of all structural members including civil, electrical, mechanical and air conditioning works, 15% etc. at site but not installed in position.
 - iv) On completion and delivery at site of all caligraphical art work.
