Development of a Housing scheme in Zone-5 Islamabad over an area of 2500 acres of land under a joint venture agreement between M/s Hertz International (Pvt) Ltd. and CDA.

Decision

The following broad clauses of Memorandum of Understanding

(M.O.U) were approved in principle, for a Joint Venture to be executed between CDA and M/s Hertz International(Pvt) Ltd.:-

- i) M/s Hertz. International (Pvt) Ltd. shall finance and be directly responsible to acquire 2,500 acres of land in Zone-5, ICT without the involvement of the CDA, and the ownership of land so acquired shall be transferred in the name of the CDA.
- ii) CDA shall prepare the layout plan of the proposed housing scheme, prepare designing of all the services and shall develop the housing scheme in consultation with M/s

 Hertz International (Pvt) Ltd.
- iii) CDA shall look after the marketing and disposal of the plots of the scheme on behalf of the sponsor.
- iv) The account of the joint venture shall be maintained in the CDA and the sponsor shall have the access to the balance sheet of the account.
- v) Necessary development work of the housing scheme will be executed by the CDA out of the receipt of sale of plots by the CDA.

- vi) The Joint Venture will be run on self-financing basis and no financial obligation will be borne by the CDA.
- vii). The profit sharing of the proposed scheme shall be as under:
 - a) 80% of the profit shall go to M/s Hertz International (Pvt) Ltd.
 - b) 20% of the profit shall go to the CDA.
- viii) CDA Shall not be responsible to any liability to the loss of the scheme and all losses, if any, shall be borne by the sponsor.
 - ix) The joint venture of the proposed housing scheme shall be controlled by a Board of Management as under:
 - a) The Chairman of the Board of Management shall be the Chairman, CDA.
 - Two members shall be drawn from M/s Hertz
 International (Pvt) Ltd. and shall comprise
 Mr. Zahid Shafiq and Mr. Manscor Ahmed.
 - Two members shall be drawn from the CDA and shall comprise the DDG(Planning) and the DDG(Works-II), CDA.
