The Board again examined two models of 'C' type mosques produced by Mr. Anwar Said and Mr. N. Pasha respectively. Again while expressing its appreciation of the work put in by Mr. Pasha, the Board did not find possible to change their previous decision. IV. REQUEST FOR THE WORKING DRAWING OF HOUSES & MOSQUES
