- 5. The Board confirmed the minutes of the 7th Board Meeting held on 13-06-2000.
- 6. The items of agenda for the Board Meeting were then taken up. Salient points of discussion and decisions are as follows: -
  - 6.1 Development of Site for Car Bazar and licensing on annual basis.

6.4 Review of the Rehabilitation Policy 1996.

The Board approved the proposed amendments for incorporation in Rehabilitation Policy, 1996 as Section 10 as under:-

- i) All adult affectees who are independent owners of land/BUP be allowed to avail of **one rehabilitation benefit** against their individually owned property which has been awarded payment of compensation.
- The affectees be allotted plots in Sector I-14 @ Rs. 300/- per sq. yard without imposing mandatory requirement of 300 sq.ft. provided he/she has lost to acquisition a proper built up structure as per award. In case of acquired BUP consisting of only one room the requirement of 300 Sft of BUP may not be made applicable. However, in case of a house having more than one rooms this requirement will stand.
- The affectees be allowed to lift Malba without deduction of 15% charges within two months of encashment of payment of compensation after which Director Enforcement will go ahead with the demolition operation.

- iv) In case where only awards of land without BUP have been announced, date of acquisition of BUP be taken as date of announcement of award of BUP.
- v) In case, the original awardee has expired, his legal heirs who are not entitled to their own rehabilitation benefit be allowed to claim this rehabilitation benefit as inheritance provided the affecttees are still in occupation of the area at the time of taking over possession.
- vi) In all other respects all such cases will be dealt with in accordance with the Rehabilitation Policy, 1996.

6.19 NON-AGENDA ITEM

CDA Board approved the proposal in principle as under:-

Annual payment with 100% increase in G&I series 200% increase in F-Series & E-Series with reduced exemptions with the change that plots of 356 sq. yards or more in G&I series should be combined with F&E series for the purpose of charging of Property Tax. The exemption of 75% be reduced to 60% in case of retired Govt. Servants and their spouses including CDA retired employees upto the size of the plots measuring 600 sq. yards. The concession of 10% as rebate against the payment upto 30<sup>th</sup> September shall be reduced to 5%. The presently applicable 10% surcharge on outstanding amounts of tax for the previous years shall be replaced @ 1.5% per month of the defaulted period. The taxation proposal and programme should be advertised in the press upto 20<sup>th</sup> July 2000 as required under Imposition of Tax Rules 1981. The proposal regarding enhancement of tax on commercial plots/land should be put up by 10<sup>th</sup> of July 2000.
