8.2 GRANT OF PRESIDENT HOUSE ALLOWANCE TO CDA EMPLOYEES BPS-1 TO 16 (NON GAZETTED) POSTED AT AIWAN-E-SADAR BUILDING.

DECISION

The summary was discussed in depth. Director Accounts apprised to the Board that relevant Assignment Account for Pay & Allowances allocated by the Federal Government for Aiwan-e-Sadr is already in deficit from which the expenditure for the subject allowance is proposed to be incurred. No funds will be available to incur the expenditure on proposed allowance from maintenance grant. Under such circumstances where CDA is already burdened financially to meet this shortfall, the Board did not agreed to the proposal which will further increase the load on CDA.

The matter of president house allowance being given to BS 16 & above officers as per earlier Board decision dated 01-03-2016 was also discussed where in the said allowance was to be paid from maintenance grant. The Board decided that in order to implement the Board decision as per its actual spirit, the President House Allowance approved for officers (BPS-16 and above) vide Board decision No. 10717/1296/BM-SCB/2016/ dated 01-03-2016 may be stopped w.e.f. 01-07-2017 due to insufficient allocation of funds in relevant Assignment Account for Pay & Allowances till provision of sufficient funds by the Federal Government to meet this expenditure.

Furthermore, it was decided to rationalize the staff deputed at Aiwan-e-Sadr until sufficient budget is allocated by the Federal Government.
