- 7. The items of agenda for the Board meeting were then taken up. Salient points of discussion and decisions are as follows:-
 - 7.1 <u>Construction of I.J. Principal Road from Pirwadhai Intersection to Faizabad Interchange (Dual Carriage Way) Phase-II, Islamabad (Relocation of Nullah Diversion).</u>

Decision:

Board approved the proposal of changing alignment of nullah from original location (Consultant Proposal) to new alignment approved by Planning Wing, construction of bridges at Principal Road site and its connection with Service Road East I-9. Board also approved execution of these works under existing contract of construction of I.J. Principal Road Phase-II being executed by M/s. Ashraf D. Baluch. Board further directed that Consultant M/s. SAMPAK should be asked to explain the reason for designing the wrong project which has compelled CDA to make necessary changes in the alignment of nullah. In case of no reply or un-satisfactory reply, action should be initiated against the Consultant.
