The preliminary report regarding the flooding of plant room of Block 'Q', due to heavy rains on 24-6-1966, was considered and it was decided that pending finalization of the landscaping development of the Sectt. Zone adequate temporary arrang-ements should be made immediately to ensure that such damage to the valuable equipment does not occur in future. It was also desired that Mr. Menth should be asked to expedite his proposal for the landscaping of the Secretariat Area and bring it up for consideration before the Board immediately.

DISPOSAL OF CINSMA BUILDING IN ISLAMADED. Sub:

The case regarding the disposal of the cinema building in Islamabed was considered in details and it was decided that in the : first instance efforts should be made to dispose off the cinema by an outright sale in lumposum or in intalments. In the case of disposal in instalments a down-payment of Res 9 or 10 lacs should be recovered and the balance amoust should be paid in equal monthly or annual instalments within a period of 4 years, In case, however, the interested party or parties are not willing to pay the balance amount in 4 years the period may be extended to a maximum of 9 years. If there is no party who can either pay in lumosum or instalments the cinema should be leased out for a period of 10 years.

In was pointed out that the basic idea of construction of flats was to economise in the use of land, and as such it was desired that the Director Planning should first examine the proposed layout from that point of view.

The alternative designs were examined and it was desired that the revised designs should be quickly prepared, keeping in view the following considerations:

- i. The built up areas should be according to the PG . I, excluding the area of the stair-case.
- ii. Cooking facility should be provided in the verendah .
- iii. Entry should be direct into the room and not through the corridors as proposed in the designs submitted by the D.D. (Arch).
