

- ii) The relaxation of Rehabilitation Policy, 1996 would not be allowed & plots will not be put at the disposal of the Societies because such plots can only be given to affectees from whom CDA acquires land or built up property.
- A meeting be held with Societies to also explore possibility of Societies getting BUP of E-11 vacated by using their own E-11 plots and to get the E-12 & F-12 areas of former Golra Revenue Estate vacated from affectees since CDA had already given these affectees exchange land in 'E-11' which Societies had purchased in the form of "Offer letters".
