Ex-licensee has been asked to withdraw the case from court, as informed by DMA vide Memo. dated 27-3-1999. Counsel of the licensee has intimated on 14-4-1999 that application of his client may be considered sympathetically then the case will automatically be come inoperative.

Chairman desired that exlicensee should withdraw the case unconditionally in the first instance.

Decision

The case was deliberated at length and it was decided that habitable use of any of the basements provided in the Annexures to the summary should not be allowed. The proposal as contained in the attached chart was approved subject to fulfilment of the following conditions:-

- a) Prior approval of plans will be necessary. Basements constructed, otherwise shall only be regularized on payment of 100% charges (equivalent to additional floor charges applicable for the area)
- b) No services shall be allowed in the basements with exception of cases where site conditions/levels of main sewer permit for the same (duly certified by the concerned formation of CDA).
- c) In case of plots with set backs where only one basement is provided, only 70% of the basement would be allowed to house, HVAC plant while remaining part of the basement and other basements shall house only parking facilities.
- d) These basements shall be planned in such a manner that all necessary measures have been taken for rescues in case of disasters i.e. provision of adequate alternative means of escape.
- e) The level of ground floors shall not be more than 3'-6" feet above the front approach road.
