a) An alternate plot of the same size may be allotted to the allottee in model village Rawal Town in lieu of Plot No. 313 measuring 30' X 60'.

b) Being a hardship case of an allottee of limited income group, the outstanding amount of Rs. 16,800.00, as extension surcharge and Rs. 720.00 on account of other charges was condoned by the Board, as a special case.

Consultant (Law), CDA may examine this case ab-initio so as to ascertain the obligation of the CDA for the allotment of the cancelled plot either of the two applicants who claim to have purchased it in view of the fact that none of the transaction was required by CDA.

7.3 Recovery of delayed payment charges in respect of cancelled or surrendered plots.

Decision

a) Board decided that in cases of cancelled/
surrendered plots, amount equivalent to
the prescribed percentage of fore-feiture
will be recovered from the defaulter allottees'
and no delayed payment charges should be
recovered as in such cases plot is not retained
by the allottees. However, this decision of the
Board will not be applicable to the case under
decision and other past cases because the allotment
letters in those cases were issued by the Authority
on receipt of the consent of the allottee to the
laid down terms and conditions.

- b) The relevant para of the existing draft sale agreement/lease agreement may be amended immediately, in consultation with the Consultant (Law), CDA, for future cases only.
- c) The above decision will not be applicable with retrospective effect.
