Subject:- MINUTES OF THE 22<sup>ND</sup> MEETING OF CDA BOARD (SPECIAL BOARD MEETING) FOR THE YEAR 2011.

The 22<sup>nd</sup> meeting of the CDA Board (Special Board Meeting) for the year 2011 was convened on Tuesday, 15<sup>th</sup> November, 2011 at 3.00 P.M in the Conference Room of CDA Headquarters, Sector G-7/4, Islamabad with the Chairman, CDA presiding.

- 4. Chief Commissioner (ICT), Islamabad and Commissioner, Rawalpindi could not attend the meeting.
- 5. Meeting commenced with the recitation of "Bismillah" by Dr. Raja Mustafa Hyder, Secretary CDA Board.

6. The agenda items were taken up for discussion and following decisions were taken:-

### 6.1 ISSUES PERTAINING TO NORTHERN STRIP E-11.

### **DECISION**

After thorough discussion the Board decided that in order to avoid further claims by MPCHS at a later stage such amounts may be disbursed to MPCHS which have already been recommended by the Commission.

i) The Board decided that item (1) & (2) of MPCHS's claim pertaining to vacation of 518-K-9M of land and BUP and commission paid to Mr. Rasheed

Mehmood Khan for vacation of 518-K-9M of land have been referred for audit and the same are subjudice in the court. Similarly, the admissibility of Item No. 17 relating to financial charges has also been referred to the Audit Firm.

- ii) Claims of items No. 3 to 11 and 13 to 14 have already been verified and payment has been disbursed to MPCHS.
- iii) Regarding item (12) pertaining to professional charges to Advocates for court cases, the Board decided that since this amount has actually been spent by MPCHS on the project, the same may also be disbursed to MPCHS.
- iv) Overhead / administrative charges etc. (Item No. 16 of MPCHS claim) have not been paid to MPCHS. However, the Board in principle agreed that since (Development charges" as mentioned in (ii) above have already been verified and disbursed to MPCHS, payment of overhead / administrative charges etc. @ 7.5% (Item No. 16) to the extent of being already verified and disbursed may be paid to MPCHS in line with the recommendations of Planning Commission.

3. During the 20th Board meeting for the year 2011 held on 30-09-2011, it was decided that a firm of Chartered Accountants be hired by Deputy Commissioner (ICT) / Registrar Cooperatives for conducting audit of charges payable under Item No. 1, 2 and 17 and the suggested TOR for hiring of Chartered Accountants be made by Member (Estate). Member (Estate) in compliance of the CDA Board decision presented the suggested TOR for hiring of Chartered Accountants in the 22th Board meeting. The Board deliberated on the suggested Terms of Reference for appointment of Chartered Accountants by Deputy Commissioner (ICT),

Islamabad / Registrar Cooperatives and agreed on the following TOR:-

#### SUGGESTED TERMS OF REFERENCE.

- i) The Firm shall verify from the records, audit and certify for payment of the amount admissible to MPCHS under Item-1 of Annexure-1 submitted by MPCHS entitled 'Vacation of 518 K-9 M land and Built-Up-Property (BUP)' against vacation of land.
- ii) Determine the admissibility of financial charges, its amount in view of best industry practices as well as applicable laws of Pakistan.
- iii) Time frame work for the Audit is 06 weeks from the date of receipt of documents to the issuance of verification Report.
- iv) Any further information/record required may be obtained from MPCHS or CDA.

## (I) DISCUSSION ON MARGALLA RETREAT, E-11.

#### DECISION

The CDA Board reviewed the progress of Margalla Retreat Housing Project and the following decisions were taken:-

- Detail of plots category-wise to be provided to Estate Wing by Planning Wing latest by 16-11-2011.
- Estate Wing will prepare balloting schedule for the plots against which application have been received.
- iii) 16 plots of larger size are to be auctioned after balloting of the 46 plots. The 14 plots situated on undulated land will also be put up for auction after informing the candidates about the topography of these plots. If the applicants still opt to proceed further these 14 plots will also be offered through balloting. In meantime Engineering Wing will carry out landscaping of these 14 plots in an attempt to improve their topography.
- iv) The Board also decided that a presentation on the CDA website will be given by IT Wing next week and that the balloting of the 46 plots Margalla Retreat E-11, should be held on

Monday 21st November, 2011 subject to provision of data. Commercial area plot sizes be revised by Planning Wing by 18-11-2011 and then Estate Wing will put up a schedule for auction of these commercial plots to the CDA Board. Member (Estate) will also give a proposal whether commercial plots are to be auctioned concomitantly with the residential plots or later. The best option will be chosen considering present market trends and which is in the interest of the Authority.
