- Director Lands & Rehabilitation will advertise in i) the leading Newspapers inviting parties for joint venture with CDA, against the land measuring 54 acres in the northern strip of E-11, on following terms and conditions:-
- CDA shall plan the strip and the interested parties a) should submit their proposal for development of the area. CDA shall be partner in the saleable area of the strip.
- b) The interested parties shall be responsible to take over the possession and development of the strip along with service road east and north.
- c) The societies who were already operating in Sector E-11 and their issues regarding title and respective possession are clear shall be given priority.
- ii) After receiving these offers the interested parties shall be short listed and further decisions shall be taken by the CDA Board.
- The process of advertisement and pre-qualification iii) of the eligible parties shall be conducted under direct supervision of Member (Estate).
- Planning Wing shall plan this strip to be offered for iv) joint venture.
