8.1 Re-Organization of Engineering Wing

It was decided that the decision of the Commissioner CDA dated 30-7-1997 to the extent of original awards in respect of villages falling in Sector D-12 & E-12 is accepted. However, further allotment of residential plots to the affectees should be made only on handing over of physical possession of the land/BUP by them. This too will be part of the over all settlement. No piecemeal award of rehabilitation benefit is allowed.

Till then the procedure presently in paras 447 to 454 of Capital Development Authority, Procedure Manual, Part III-Accounting Procedure, be followed for the payment of monetary compensation to the affectees. This procedure will be applicable to all payments yet to be made whether these pertain to the awards already announced or made subsequently.
