I. PRELIMINARY LANDSCAPE SKETCHES FOR THREE STOREYED OFFICE BLOCK, SERVICES BLOCK AND SECURITY ZONE.

The Board considered a summary on the captioned subject presented by Mr. Robert Eaten, Resident Architect of M/S D.L.A. The Board approved the Security Cordon around the President's House. The Board was informed that the Security Arrangements had already been discussed with the President's House staff. However, as regards approach road and stone pitching on south-eastern side of the President's House the Board decided to reger the matter again to the Architect with the views and observations of the Authority. It was felt that stone pitching would be costly and was also likely to affect the looks of the building. Mr. Robert Eaton expressed the desire to finish his work by September 30th, 1969 and therefore requested for an early decision on the two points.

## IV. DESIGN OF FIRE SUB-STATION IN SECTOR I-9 ISLAMABAD.

carrel/69 Mr. Hashim, Deputy Director Architecture presented a design to the Board for Fire Sub-Station in sector I-9, of Islamabad. While examining the accommodation provided in the design, the Board drew the attention of the Architecture Directorate to the necessity of seeking clearance from the Board about the needs given by various Directorates before starting designs of various buildings. In this particular case the Board decided to ask the Director Municipal Administration to justify the need and its extent regarding residential accommodation within the Fire Sub-Station as was given to Director Architecture by the Fire Officer before the design could be considered for approval.

Director Architecture presented two designs prepared by Mr. Anwar Saeed and Mr. Naeem Shah respectively. The design prepared by Mr. Anwar Saeed was approved by the Board subject to a few conditions. Director Architecture was required to bring a complete model in the next Board meeting Will with the suggested modifications. He was also to ensure due continuity of 'SUFS' (Rows) in the design. Under the present arrangements, it seemed as though the continuity could not be maintained.
